**ARTICLE VI. Election of Officers, Section 2. Elections**

Election shall be by ballots published in a variety of media (including the Club’s website, newsletter and/or email) no later than the second Monday of October (October 12<sup>th</sup>, 2020). All ballots must be signed by the voting member, placed in a sealed envelope, and received by the Secretary via U.S. Mail or by common carrier no later than the Thursday (October 29<sup>th</sup>, 2020) before the next regular board meeting (November 4<sup>th</sup>, 2020). The Secretary shall return the ballots unopened to the next regular board meeting (November 4<sup>th</sup>, 2020). The Secretary and two other members in good standing, appointed by the President, shall then count the ballots and then report the results to the Board of Directors. A member shall be entitled to only one vote regardless of multiple memberships.
