## CHICAGO REGION CONCOURS CLASSES AND NOTES

These guidelines are formulated to promote enthusiasm and encourage participation by all members of the club.

They apply to all scheduled Concours events.



- 1. Only Chicago Region members will be eligible for Regional Points and Year End Points/Trophies.
- 2. At the first Concours entered, the entrant will be the only person to determine the Class to which his/her car belongs on the basis of preparation.
- 3. A Class must be declared at registration. Once a vehicle is registered, no refunds will be issued for any registration fees.
- 4. Entrants of the same car in subsequent Concours events during the year must remain in the same class originally entered, or they may elect to move up a Class. <u>Entrants may not regress to a lower Class</u>.
- 5. Once judging begins, no additional cars may be added to a Class.
  - A. Once judging begins, all cleaning and dusting must conclude. Violation may result in disqualification for that event.
  - B. Once the cars are placed for judging, all vehicles must have parking brake engaged and ignition keys removed from the vehicle. Vehicles should not be started during judging.
  - C. Entrants must be with the vehicle for judging. Judges will not open compartments or remove items for judging. The entrant is responsible for presenting the vehicle for judging.
- 6. One car shall make a Class.
- 7. No bonus points will be awarded for authenticity/originality, and no penalty imposed for the lack thereof. Judging shall be based solely on the **cleanliness and condition** of the car.
- 8. Cars will be shown as delivered from the Porsche factory. All cars must possess a <u>Porsche</u> VIN number. Removable protective bras and seat covers must be removed prior to judging. Convertible tops must be fully raised. I-Pass Transponders may remain in the vehicle. Coins, maps, garage door openers, radar detectors, CD's and other personal items must be removed prior to judging.
- 9. Concours Classes:

(Each section indicated will be fully judged using the appropriate section judging sheet)

## **Touring and Grand Touring:**

240 points

Grand Touring: exterior, interior, storage, undercarriage

(Models 991 (2013 – On), All Boxster, All Cayman, Full electric models)

Touring: exterior, interior, storage, engine

(All Models not eligible for Grand Touring)

Show: exterior, interior, storage175 pointsExhibition: exterior only75 pointsCorral: display only, not judged.0 points

- 10. Event awards within each class will be determined based upon the Total Concours Score. In the event multiple entrants achieve the same Total Concours Score, placement will be awarded based upon the highest score in a section, in the following order: exterior, interior, storage, engine and undercarriage. Should the need arise, the class judging team may re-judge any cars with identical initial scores in all sections.
- 11. Judging for all classes will be performed on a demerit basis and will utilize 0.1 point deduction for each demerit as deemed appropriate by the judge.

12. Schedule of points leading to Year End Trophies will be skewed in favor of the higher classes as shown:

Class	1st	2nd	3rd	4th	5th	6th
Touring and Grand Touring	15	13	11	9	7	5
Show	12	10	8	6	4	2
Exhibition	9	7	5	3	1	0

- 13. If two participants are entered in one car, both participants must be physically present at the Concours to be awarded Year End Points.
  - **NOTE:** Concours participants may elect to enter an additional or different car throughout the year. Points earned are the sum of an individual car, not the combination of more than one car. Points earned do not necessarily earn trophies!
- 14. In addition to the point system specified in the PCA Chicago Region scoring sheets, the following points will be assigned for mileage. Mileage points will be awarded in all classes with a maximum of 1.0 point allowed:

Less than 20,000 Miles = 0.0 points 20,001 - 40,000 Miles = 0.2 points 40,001 - 60,000 Miles = 0.4 points 60,001 - 80,000 Miles = 0.6 points 80,001 - 100,000 Miles = 0.8 points Greater than 100,000 Miles = 1.0 points

- 15. To continue the spirit of promoting enthusiasm and encouraging participation, an additional 5.0 points will be awarded at each Concours to any car that has positively indicated the car was fully driven to the event. No additional points will be awarded to any car that was not driven to the event.
  - A. In the event a participant is determined to untruthfully answer this question on their scoring sheet for any event, the car will be disqualified and deemed not eligible for year end points and awards.
- 16. A majority of First Place awards in any class by any one car/entrant during one Concours season shall result in that entrant's promotion to the next higher Concours Class for the next season.
- 17. At the discretion of the Event Chairperson or Concours Chair, the following awards/trophies may be added to any Concours event:
  - A. The "People's Choice" trophy shall be awarded solely on the basis of the popular numerical votes cast by entrants. All those participants in attendance are eligible to vote and are allowed one ballot.
  - B. The "Best of Show" trophy shall be awarded based solely on the subjective appeal of the car to the Judges which best represents the spirit of Concours.
  - **NOTE:** In the interest of fairness, no one car will be eligible to win both the People's Choice and Best of Show trophies at any one event. No one car will be eligible to win the Best of Show trophy more than once in a given year. These awards do not in any way influence the Year End Points/Trophies.
- 18. Disputes the day of an event will be resolved by a panel consisting of the Event Chair, Concours Chair and Concours Co-Chairs in attendance. Their decision is final and binding.
