## Secretary's Report: (Todd Conforti)

With a quorum present Neil MacDonald called the meeting to order at 7:32 PM.

Minutes from 11/1/17 meeting were discussed. A copy was circulated via email to all Board Members and Coordinators. A motion was made to accept the minutes.

# President's Report: (Neil MacDonald)

MacDonald welcomed the new board members and he hopes that the Board will continue its effort to guide the Club into the next 60 years with the same care and vision that it has exercise for the past 60 years. He will present additional comments, if any, in the coordinator reports that follow.

### Treasurer's Report: (Robert Danko)

Danko was pleased to take over for previous Treasurer David Angelus and thanks him for his hard work to automate many of the accounting tasks and in particular interfacing with Clubregistration.net, implementing enhanced financial controls, implementing Square credit card processing, and expanded documentation of the Club's various financial transactions.

Danko reports overall the Club is in excellent financial condition with a YOY increase in assets, noting that while Income was down in FY2017 compared to FY2016 (an outstanding year), it was nevertheless in line with FY2015. The decline in income was in part due to changes in marketing strategy by a principal Club sponsor, and the termination, after one year, of a two-year Club race series by the national organizer of the series. The treasurer also noted an increase in certain event expenses, due in part to the Board's effort to "give back" to our members by absorbing some track rental increases, and by subsidizing and expanding the number of social events held. Largest income source in December was the Dinner Dance; largest expenses were the Dinner Dance, year-end awards, *Scene* publication, and new AX timing equipment, which was purchased at the end of the 2017 season.

# **Autocross Report (Scott McClement)**

McClement reports that all AX events for 2018 are booked at Boomers which is advantageous due to having the Club's storage locker situated close by.
