#### **Steve Kwon – Discount Tires**

There are no issues with timing and scoring equipment.

## Blackhawk Farms Report: (Todd Conforti, Peter Hackenson, Peter Bukantis)

Novice Day held on May 6, 2022, was a great event, despite a rainy day. There were 77 paid drivers, 40 novices, with eight no shows. There were no incidents.

Our next event at Blackhawk is scheduled for June 24, 2022. We currently have 68 paid drivers, 18 novices, nine in the black/white group. Additional instructors are needed. SCCA members will be in their own run group.

## Autobahn DE: (Glenn DeWeirdt/Reported by Dana Comolli)

The SUV event is open with eighteen registrants so far. We have several instructors in place. This event is only open to members which has resulted in new memberships. The Exchange claims to have sent out an email to customers who have purchased a Macan or Cayenne, but we have not been able to confirm that the emails have been received. Dana will follow up with The Exchange. The next payment for this event is due by June 29,2022. The Exchange is offering tech and brake flush for a Cayenne or Macan for \$100.00 for anyone participating in the event. Autobahn can offer up to 35 rental helmets if necessary.

A deposit has been made for the full track event on October 17, 2022.

We have started discussions with Autobahn about locking in dates for 2023.

#### Gingerman Report: (Glenn DeWeirdt//Reported by Stanley Sangdahl)

Registration is open with thirteen registered so far. Macon group will run on Sunday

#### Road America Report: (Cheryl Lehman Collier)

RADE was successful. No incidents for the first time in PCA history. There was \$1660.00 raised for SparkShop, with \$880.00 coming from the touring event, \$620.00 through ClubReg and \$160.00 from sales of T-shirts, lanterns and hats.

The stewards for TRAC have been assigned and a meeting is scheduled with them for June 15, 2022.

Cheryl met with Susan Shire and learned that we can offer Lapping sessions or Test & Tune for club racers on Friday. The benefit to Test & Tune is that we can give decals and wristbands for sprints and enduro on Friday. The driver would then need to return to registration for logbooks and tech stickers on Saturday. DE rules would apply but we will expand passing rules in the corners as long as a "point" is given.

We have taken a full-page ad in Club Race News for 2022 TRAC to counterbalance the Indy event which is not a points event so it is not likely that we will lose many drivers.

## **Chief Driving Instructor's Report: (John Ruther)**

We had enough instructors for Novice Day at Blackhawk. Dana Comolli and John Ruther did the classroom sessions. The rain gave everyone the opportunity to gain experience on a wet track.

RADE had more instructors than novices so some newer driver or drivers new to Road America were assigned an instructor.

We need more instructors for Blackhawk on June 24, 2022.

A suggestion was made to provide instructors with copies of blank track maps to mark up and make comments that would help their student.

## **Safety Report (Todd Conforti)**

There were no incidents at Blackhawk (May 6, 2022) or RADE (May 25 - 16, 2022).

There is a recall of Recaro SPG XL seats manufactured from 2017 to 2022. The defect can cause cracks in the seat shell resulting in a possible detachment of the shell from the adaptor. Recaro is expecting replacement seats to be available in October 2022. We will check with National to see how they are managing this situation.

#### **Concours Report: (Henrique Regina, Alex Block)**

The first event scheduled for June 26, 2022, in Bolingbrook has four registrants. We are waiting for the Promenade to send an agreement for the event.

Dana Comolli will set up the Concours registration for Potters Picnic. Stanley Sangdahl will contact Rick Fisher to finalize pricing for Potters Picnic.

## Rallye Report: (Andy Skura)

Rallye #1 on May 15, 2022, had 15 teams participating. First time Rallyemasters, Les and Caroline Teichner wrote the 'Revenge Rallye' which included a trick that cause all teams to miss a checkpoint resulting in high scores for all. Rallye #2 scheduled for July 10, 2022, has been cancelled due to a lack of Rallyemasters. Rallye #3 is scheduled for August 24, 2022 and will be designed by first time Rallyemaster Chris Costis and Shannon Lange.

Andy will be doing a brief training session on the Richta app for Rallyemasters. We will also need to order prizes for rallye #4 & #5.

A motion was made to reimburse mileage equivalent to the total mileage for one run of a rallye route to the individual who drives the photographer along the rallye route to take pictures.
