Treasurer's Report (Catherine Fischer)

The financial report was distributed prior to the meeting and reviewed. The club's financial summary starts with total assets in September 2025 of \$696,889 compared to September 2024 of \$719,702. Cash assets in September 2025 were \$588,259 compared to September 2024 of \$545,301. Income for September was \$303,158 with a YTD of \$691,112, mostly due to TRAC. Our expenses were -\$269,348 and YTD of -\$626,427.

Top income sources were Events.

Total bank account balances, including checking, savings and CDs Toal \$588,259 as opposed to 2024 of \$545,301.

Charity collected YTD is \$20,360 versus \$24,144 last year.

Top receivables are Napleton, RA Sponsorship, and The Exchange as well as the incident and damage at TRAC from RA.

Events were reviewed by each, most everything did well. There will be a slight change to RA with a last-minute invoice.

Change over to cloud quick books in October.

Other issues – slight change in reporting format thanks to Dana.

President's Report (Dana Comolli)

The draft 2026 calendar is online now for collaboration and filling in dates by each coordinator. It is requested this task be completed by end of November.
